## LA ANTILLA BEACH REGULATION

(Decreto 8/06/2021)

### LETS IT BE KNOWN:

That the **beach season** begins on **15<sup>th</sup> June** and ends on **30<sup>th</sup> September** and that in order to safeguard the security, healthiness and well-beings of neighbors and residents in La Antilla, I provide the following rules about **TRAFFIC AND BEACH'S ACTIVITIES**.



**ANIMALS.-** It is forbidden having and walking dogs, horses and pets else by the sand and swimming in the sea. Under penalty, with the exception of guide dogs.



**TRAFFIC.-** It is forbidden driving and parking all kind of particular motorized vehicles by the sand, except the authorized ones by the Provincial Service of Coasts.



**NAVEGATION.-** The throwing and beaching of vessels would be only by the authorized places. Boats could sail parallel to the shore to 200 metres from the beach.



**PLAYS.-** The embarrassing and annoying ball plays are forbidden all along the swimming area. It only could be practised in authorized places and always in dry sand area near the dunes, without invade the protected area.



**FISHING.-** The angling from shore is not allowed from 10:00 h. to 22:00 h. and it will be always keeping with the fishing legislation.





**CLEANING.**- It will be used bins to throwing out all kind of waste. It is forbidden any dumping to the sea or sand, as well as the cleaning of any belongings in showers or drinking fountains.

**ACTIVITIES AND OCUPATION.**- It is remembered that the placement of canopies and any intensive activity which deprive of sand will be put out to tender.



**CAMPING.**- It is forbidden camping along the beach, as well as cooking and firing.



**ACCESS.**- Pedestrian access to the beach will be by authorized paths and making easier the priority of disabled people.

**ENVIRONMENT.**- It is forbidden collecting or catching of any plant or animal of land-maritime public knowledge.



**NOISES.**- It is forbidden making noises that disturb beach's users from rest.



**LIFEGUARD.**- It is forbidden swimming when the red flag is waving on the watchtowers placed on the beach, as well as the caution when is yellow flag. Apart from that, it is announced the availability of swimming chair for disabled people.

**HAWKING.**- Hawking will be regulate following the established law in force.

**DETERGENTS.**- It is forbidden using gels and abrasive products on the sand as well as in showers.

What is published by virtue of faculties that law confers me, according to the Beach Plan approved by the Provincial Delegation of the Ministry of the Environment and warning that the failure to comply the prescriptions will be fined according to the requirements in force.



## ATTACHMENT I: MEASURES

### GENERAL SAFETY RECOMMENDATIONS - COVID'19

- ✓ There should be a safety distance of 1,5 meters between groups out of the water.
- ✓ Face mask required during "walks" on the beach and other aquatic environments, except in the showers, regardless of the mass or not that exists in the area.
- ✓ Make responsible use of the beach and follow the instructions of the lifeguards.
